COMES NOW, Kevin S Keatley, a duly appointed, qualified and acting Deputy District Attorney of the Third Judicial District of the State of Kansas, and for and on behalf of said State gives the court to understand and be informed that:

COUNT 1

THEFT BY DECEPTION; \$25,000 TO \$100,000 K.S.A. 21-5801(a)(2),(b)(2) Level 7, Nonperson Felony
