Declaration of Jeffrey Beazizo

On June 25, 1994, I married Ann K. Reinhart (now, Ann K. Burlingame) in Falls City, Washington. We have two children together, Emily J. Beazizo (Age 9) and Colin G. Beazizo (Age 6). During the time we were married Ann continuously showed signs of anger and had outbursts of rage on a regular basis. Ann attempted to control others including our children. She lied to me, her family and others on a regular basis. We attempted counseling from five different counselors. Four of the counselors recognized Ann had the same behavior and characteristics of someone with Borderline Personality Disorder (BPD), narcissism, and obsessive compulsive disorder. Ann has never been officially diagnosed with the disorders. She would stop attending the counseling sessions before she was completely diagnosed. We divorced on July 16, 2008, after 14 years of marriage. We currently have joint custody. Since October 2010, I pick up the children on Thursday at 7 p.m. and have the kids at my residence until Sunday at 7 p.m. Ann continues the same unstable and unpredictable behavior today but with more intensity. Emily and Colin come home regularly saying Ann has yelled at them. Emily and Colin say Ann keeps calling them "dumb" and "stupid." I can see the kids are

1 getting frustrated with Ann's comments. I work with Emily and Colin doing their
2 homework while they are with me. The kids become upset if their homework is not
3 perfect in fear Ann will yell at them when they go back to her. Emily stated that Ann
4 calls me "stupid" in front of the kids on a regular basis. The kids will spend hours doing
5 45 minutes of homework erasing every error to make it perfect. They will not try to just
6 spell out words as they want it to be correct to please Ann. On February 10, 2011, Emily
7 told me Ann had made threats to kill the kids over homework.

8 Sometimes, Colin would arrive home after Ann cut his hair. There would be large
9 chunks of hair missing and it looked terrible. Colin was becoming embarrassed so I
10 would take him to the local barber to have it corrected. Colin would be dressed in dirty
11 clothes when I attended school events. He would be wearing jeans with holes and soiled
12 with dirt.

13 Ann keeps her vehicle a mess with items that are thrown about and unsecure on the floor
14 and seats. This is a danger to the children and passengers who ride in the vehicle. Ann's
15 residence is the same way and is full of stuff. She continues to hoard things and bring
16 more things into the residence. She has piles of stuff stacked up everywhere. One
17 Thursday, when they arrived at Locksloy Fields in Lake Stevens I observed Ann taking a
18 small play structure that was being giving away for free. Ann will grab free items
19 alongside the road and take them to her residence. Everything at the residence is in
20 disarray and is very unsafe to the children, especially her youngest daughter who just
21 turned one year old. The counters are cluttered with stuff which could be easily pulled
22 down by the children. Frequently, one can't even walk around because of the mess on
23 the floors. There is an area where the young daughter plays which has several items that
24 are dangerous. I have taken several photographs throughout the past year showing the
25 residence at different times.

26 The house continues to become messier and now there is an issue with black mold
27 growing in the crawl space of the residence. The house has a nasty and musty smell as

1 you enter it. I have noticed the kids getting sick more while being over there. Emily has
2 been diagnosed with asthma, and I have noticed an increase in her wheezing.

3 Ann has caused emotional stress around the children which started early in their lives.

4 My son was going through pottng training and would occasionally mess in his pants.

5 One time, according to Emily, who witnessed the incident, Ann became upset with Colin
6 because he had pooped in his pants. Emily observed Ann smear poop on Colin's leg and
7 heard Ann tell Colin that next time she would smear it over his face. Colin suffers from
8 encopresis, which I have taken him to the doctor twice to be checked out. The doctor
9 could not medically find anything that would have caused this except for stress.

10 In January 2008, I returned home from work after working nights. I was just lying down
11 in bed when I heard Emily screaming for me to come to her. Ann was giving the kids a
12 bath in the kid's bathroom. I walked into the bathroom and observed Ann holding Emily
13 by the forehead and pony tail pulling Emily's head under the faucet. Emily was
14 screaming for Ann to stop. Ann was very upset and yelled "you are leaving anyways so I
15 will handle this. Emily won't listen." I told Ann to release Emily and leave the
16 bathroom. Emily was scared to death. This event caused Emily to be in fear of water
17 until just recently.

18 In July 2008, Ann travelled to North Dakota for a family reunion. I received a
19 frightening call from Emily saying she needed to talk to me because Ann did something
20 to her. Emily quickly hung up the phone because Ann was coming to the car. Sometime
21 during the trip, Ann became upset with Emily because she would not sit down. Ann
22 forcibly grabbed onto Emily, causing severe bruising on Emily's arm and leg. Emily had
23 a marked cause by Ann's finger penetrating into her arm. They returned home on July 6,
24 2008. The marks were still very visible so I called the Snohomish County Sheriff's Office
25 to make a complaint. I took photographs of Emily's mark.

26 I called CPS in October 2010 because I was concerned with the welfare of my children
27 and Ann's other daughter. I noticed the kids were not being bathed on a regular basis.

28 They would come home saying they were very hungry and eat a lot of food. I had arrived

1 at the residence to return the children. The front porch was covered with moldy orange
2 peels and garbage. As we opened the front door there was a bounce house folded up
3 behind the door. We had to climb over the bounce house to walk down the hallway. The
4 upstairs hallway was filled with bookshelves, clothes and furniture. This caused me
5 concern for if there was a fire in the residence the kids could not get out. Also, the kids
6 were sleeping together in the same room with two of them sleeping on the floor of my
7 son's room. Ann is currently sleeping with Colin in his bed with Emily sleeping on the
8 floor next to them. Ann's residence is over 2800 square feet with four bedrooms. This
9 action is causing the kids to not want to sleep alone.

10 On February 24, 2011, I took Emily to counseling at Fountaingate in Marysville.
11 Recently, Emily admitted that Ann paid her \$96 the week before counseling to not say
12 anything. Emily stated Ann interrogated her so much that Emily felt unsafe to say
13 anything to the counselor in fear she would get in trouble from Ann. Ann stated the
14 money was for Emily playing basketball. She said she was paying Emily \$5 for each
15 basket and rebound she got during her basketball game.

16 On April 24, 2011, Emily return to my house with her finger chewed raw. Emily was
17 trying to hide the marks from me. I confronted her about why she was chewing the side
18 of her finger causing it to bleed. This is a new and more serious behavior that concerns
19 me even more. Emily wouldn't say why she chewed it.

20 On April 28, 2011, Colin arrived at his baseball game late with Ann. I noticed Colin was
21 walking stiff and grabbing his stomach. Colin made the statement he was hungry
22 because they had not eaten dinner. When we arrived at our house, Colin immediately ran
23 from the vehicle to the upstairs bathroom. I could hear him crying and yelling for me.
24 When I walked into the bathroom, I noticed Colin had his pants down and his underwear
25 was solid with dry poop. I noticed his bottom was really red, with a rash and covered
26 with dried poop. Colin stated he had been this way for two days. I asked him why he
27 didn't say anything to Ann and Colin stated that he didn't want to get into trouble.

1 On May 7, 2011, I dropped the kids off to Ann. That day Colin and I had been playing,
2 wrestling and hanging out with Emily. We all had eaten the same thing. On the way to
3 Ann's house, I noticed Colin getting quiet and he did not want to go to Ann's house.
4 About an hour after dropping the kids off, Ann called me stating I poisoned Colin
5 because he was throwing up. On May 12, Colin and Emily returned to my residence.
6 Colin made the statement I poisoned him on Saturday because he threw up. Emily was
7 calling me mean. Emily stated "mom will lose her house and it will be your fault unless
8 you babysit Bella for her while she works."

9 On May 22, 2011, I delivered the kids to Ann's residence. I returned some Oral-B
10 toothbrushes, which the kids had been using at my house. Ann immediately became
11 upset and started yelling at Emily because Ann had just purchased some toothbrushes for
12 the kids. I told Ann she had no reason to yell at Emily and it didn't matter about the
13 toothbrushes. Ann continued to exhibit anger and continued to yell at Emily.

14 Ann displays a behavior of fear of being alone. Ann continues to have unstable
15 relationships jumping from one person to another and another. She causes emotional
16 stress on the children by having so many relationships and taking the children with her on
17 dates. On May 18, 2011, Ann took the kids to Bellevue Square Mall to meet her current
18 fiancée Matt Uran at the Lego store. According to the children they got home at 9:30
19 p.m. that night. The children had school the next day. During some of the relationships,
20 I know by Emily and Colin's admission Ann had the kids sleeping on the floor of her
21 boyfriend's residences.

22 Within one of year of our divorce she was engaged to three separate men. She had two
23 ex-marital affairs that I know of and she admitted to during our marriage. She started a
24 relationship with Gordon Gazaway right after I moved out of the house at 2922 113th
25 Ave Se Lake Stevens, Washington at the end of January 2008. Ann became engaged to
26 Gazaway three days after our divorce was final. In December 2010, I was informed
27 Gazaway was arrested by ICE for Child Pornography and that Emily might have been a
28 victim. Later, a case was investigated but it was proven that Emily was not a victim.

1 Ann broke up with Gazaway in August 2008 and immediately started another relationship
2 on the same day. She met an old classmate who was handicapped and confined to a
3 wheelchair. Ann started taking the children to his residence. She kept the children up
4 late at night even on school nights. The kids would miss school at times because of this
5 behavior. She continued her relationship until May 2009, when she met her current
6 husband, Gary Burlingame. Ann became pregnant immediately and then married Gary in
7 August 2009. Ann delivered her daughter Sybella Burlingame on April 2, 2010. She is
8 currently married, but as mentioned previously, is now engaged to be married again in
9 November 2011 to another gentleman she went to high school with. This gentleman,
10 Matt Uran, was severally injured after crashing his helicopter while in the military. Matt
11 has a traumatic brain injury in which he can't care for himself, can't drive and has
12 problems with decision-making. He has the mental capacity of a 13-14 year old child.
13 He received disability payments of \$6000 a month.

14 The children need a stable and stress free environment which to live in. The children
15 need to feel secure so their health and emotional state doesn't suffer. I have provided
16 them with a loving and stable living environment making sure their daily needs are met.
17 They are happy when they are with me and always look forward to coming home. I am
18 active in the kid's life, coaching Colin's baseball and volunteering at the kid's Awana
19 program. The kids need to learn proper behavior. They need be held accountable for
20 their actions in a respectful and proper manner. I don't want the kids to be bewildered by
21 Ann's action and comments anymore. Ann's comments, actions and relationships have
22 proven she is mentally unstable and unpredictable.

23 I declare under penalty of perjury under the laws of the state of Washington that the
24 foregoing is true and correct.
